

## Basketball Australia Policy

### Australian Junior Championships Spectator Photography and Videography

BA will:

1. Never give out personal information about the child. This includes surname, address, telephone number etc.
2. Take all reasonable precautions to ensure that when photographs are used they will not include identifying information - such as full names, addresses etc
3. Be very careful with the information that we utilise.
4. Only allow video-taping and/or photographs of any teams or individual athletes of games by:
  - a. State/Territory team officials who have signed a Member Protection Statement. All videoing will only be allowed in designated areas of the stadium. The video cameras are to be battery operated and hand held only.
  - b. Family and /or friends of participants at the Championships, who have registered with Basketball Australia for the purposes of taking video and /or photographs and have signed a video/photo permission form acknowledging they will comply with Basketball Australia's policy in regards to the use of photos. A person who has registered to utilize a camera is only allowed to take photos/videos of the team that they are associated with and can not take photos or videos on behalf of another person, family or team. Any person taking photos/videos of other games will have their pass withdrawn.
  - c. People not associated with any participants at the championships who wish to video for reasonable educational purposes, who have registered with Basketball Australia for the purposes of taking video and have signed a photo permission form acknowledging they will comply with Basketball Australia's policy.
  - d. Flash Photography is not allowed and no photos are to be taken from the baseline of the court. Basketball Australia reserves the right to refuse registration and use of any camera equipment that may be used for commercial purposes.
5. It is not our intention for this policy to prevent friends and family of participants from taking their own point and shoot images of their children; Simply an endeavour to monitor this process and protect athlete privacy and the rights of the tournament official photographers who have entered into a commercial arrangement with Basketball Australia.
- e. All photographers/videographers from local media must show accreditation before gaining an access pass.

An authorised pass will be issued to each individual wishing to take photographs or videos. This pass must be visible at all times when taking photos or videos. If your pass is not visible you will not be permitted to continue. Anyone taking photos from the baseline (even if seated) or video outside of the designated area will not be allowed to continue. Passes are non transferrable.

## PASS HOLDER RULES

- ✓ Basketball Australia have commercial arrangements with respect to video and photos taken at this event. These partnerships need to be respected at all times.
- ✓ Pass holders are not permitted to stream games to any platform.
- ✓ Pass holders are not permitted to video full games. For access to full game footage please contact BA Pathways.
- ✓ Pass holders are not permitted to take photos or videos on behalf of another person, family or team.
- ✓ Passes must be visible at all times
- ✓ Passes are non-transferrable
- ✓ Flash photography is not permitted under any circumstance
- ✓ Pass holders are not permitted to take photos or videos from the baseline of the court or in the seating on the baseline.
- ✓ Pass holders must remain in allocated seating and not move seats around the court.
- ✓ Pass holders cannot enter the court or team benches
- ✓ Pass holders are not permitted to use tripods or other equipment that may impede on other spectators view or use of space.
